I further understand that, if mediation does not result in a resolution of the disciplinary action issued to me, I will still have the right to appeal the issuance of this discipline through the appeal process provided for in Section 650 of the ELM.
- I understand that **this request for mediation form (or written request) and a copy of the discipline must be sent within ten (10) calendar days** from my receipt of an applicable disciplinary action to the **ELM 650 Mediation Facilitator, Manager EEO Compliance and Appeals (Pacific and Western Areas), HQ EEO Field Operations, Region 1, P.O. Box 880546 San Francisco CA 94188-0546. (Employees at Postal Service Headquarters and Headquarters Field Units and employees of the Inspection Service should notify the ELM 650 Facilitator at Postal Service Headquarters. The discipline must show date received by you.** Additionally, I will notify the management official who issued the action and the appropriate District, Area, or Headquarters Labor Relations office of my intention to participate in ELM 650 mediation.
